100.7 WJTQ's "Massage Envy" Contest Official Rules

Eligibility. (c) Include in the comment: #sweepstakes.

Station is not responsible for lost, late, incomplete, invalid, unintelligible, inappropriate or misdirected registrations, all of which will be disqualified. The "authorized account holder" is the natural person assigned the telephone number by the

On or about 4:00 p.m. CT each weekday during the Contest Period (each, a "Selection Day"), Station will select one (1) entry in a random drawing from among all valid entries received through 4:00 p.m. CT on that Selection Day. The winning entrant will be contacted using Facebook messenger and/or the email address and/or telephone number provided with his/her Facebook profile and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within twenty-four (24) hours of notification will result in disqualification.
- 5. Verification of Potential Winner.
